COLLEGE COUNCIL:

The purpose of College Council is to follow the College Governance System which is to foster the participation and contribution of the faculty and staff to the educational mission of the College. Council provides the framework for the networking and support needed to carry out the general work of the College. Several Standing Committees report to College Council and bring policy recommendations for action to the Council. They will be the forum for final discussion of matters before recommendation to the President of the College for disposition.

COLLEGE AFFAIRS:

This committee shall make recommendations to the College Council and be called upon by the administration to assist in policy implementation in the following areas: Budget/Fiscal, Campus needs assessment and planning, Space Allocation/Facilities/Safety (OSHA), Security, Marketing/Publicity/Community Relations.

CURRICULUM & ACADEMIC POLICY:

This committee shall make recommendations to the College Council and be called upon by the administration to assist in policy implementation in the following areas: New programs & courses, Academic calendar, Academic standing, Graduation requirements, Grading policy, Substitution, Waiver, Withdrawal, CLEP, Independent study.

PROGRAMS & SERVICES EVALUATION:

This committee shall make recommendations to the College Council and be called upon by the administration to assist in policy implementation in the following areas: Assessment, Accreditation, Program Evaluation (subject to applicable Board policies), Services Evaluation.

FACULTY & STAFF DEVELOPMENT:

This committee shall make recommendations to the College Council and be called upon by the administration to assist in policy implementation in the following areas: Faculty and staff recruiting, Teaching techniques development, Center for Teaching, Awards and emeritus recommendations, Faculty/Staff Handbook, Faculty/Staff orientation, Professional Development events, Cultural programs, Wellness, Distance Learning.

INFORMATION RESOURCES MANAGEMENT:

This committee shall make recommendations to the College Council and be called upon by the administration to assist in policy implementation in the following areas. Standards for hardware and software purchases for classroom use, Campus-wide plans for networking, Electronic access to institutional information, local and national databases and library resources, LANS, Local databases and multimedia, Security standards, Lab access and security, Institutional research, Distance Learning.

STUDENT DEVELOPMENT:

This committee shall make recommendations to the College Council and be called upon by the administration to assist in policy implementation in the following areas: Student recruitment and retention, Registration procedures, Placement Testing, Academic Advising, Orientation, Scholarships and Awards, Graduation procedures, and Student Activities.
