The answer given by this year's commencement speaker, Tanya Henderson, an MXCC graduate and well known human rights activist and attorney, is persistence. The opportunity to persist, to "begin again" was what Middlesex Community College offered Tanya as she grew from an uninspired high school student to an inspiring international advocate for human rights, particularly women's rights and empowerment, with the Ministry for Social Affairs in Lebanon, the Women's International League for Peace, and now Mina's List, an organization she founded to empower women's political leadership globally. She credits the faculty and staff at MXCC for helping her to develop her academic and personal goals and the tenacity to overcome the obstacles in her way – repeatedly.

Tanya is an example of extraordinary student success, but her achievements are replicated in some way every day by students at MXCC as they "recreate, rebuild, or completely redefine their pathways" often with the support of the Foundation through scholarships that meet their needs and fund new programs that help them to overcome obstacles. The donors listed in this annual report are creating the opportunities that students like Tanya need to realize their full potential, to keep on learning, to create a better world for themselves, their families, their communities and for all of us who depend on them to sustain a world of opportunity.


# FROM THE ASSOCIATE DEAN OF DEVELOPMENT

# Endowed Scholarship Awards

### High School Scholarship Program

Since the program's establishment in February 2013, the High School Scholarship Program has expanded to involve 20 area high schools in Middlesex County, Wallingford, Rocky Hill and Meriden. Each high school may nominate three students for consideration for a \$1000 scholarship for the upcoming MxCC academic year. Selected students must have an average or above average GPA, a commitment to attend MxCC as a full time student, and a record of community service. Students who choose to continue a second year at MxCC and maintain good academic standing are eligible for additional scholarship funds during the next academic year.

In 2015, the Foundation awarded 17 scholarships to deserving local high school seniors, ensuring that the student body at MxCC has greater representation from all the communities in our region. Traditionally, community college students continue to live and work in Connecticut after they graduate, often entering careers in the health, human services, and public safety fields that support our communities. Ensuring that every student has the opportunity for higher education is a challenge for Connecticut's schools and a guiding principle for the work of the Foundation.

# Scholarship Task Force Report

A major initiative in 2015 was undertaken by a Scholarship Task Force created by the Foundation Board of Directors to review the application and selection process for scholarships awarded by the Foundation. Recommendations from the group chaired by President Emeritus Jonathan Daube and Professor Judith Felton, a long time faculty representative to the Foundation, call for increasing funding for scholarships and creating an awards process that is:

- simplified and streamlined
- coordinated with college faculty, administration, and staff involved in financial aid
- inclusive and comprehensive in relation to student applications and performance
- focused on aligning donor intent with student needs

The Scholarship Committee, chaired by Foundation members Richard Muniz and Professor Rebecca Loew, introduced many improvements during the 2015 awards season which were included in the Task Force review. Over \$55,000 was awarded in scholarships in Spring 2015 including seventeen

\$1,000 scholarships to students from the region's high schools.

# **FOUNDATION GRANTS TO PROGRAMS**

During the past summer, the Middlesex Community College Foundation awarded ten grants to MxCC faculty and staff through the Foundation's New Day Fund to support innovative and evidence-based projects that advance student success. This is the third year the Foundation has awarded grants of this type. Grants are to be used during the 2015-2016 academic year.

# Grants awarded for 2015-2016

- Honors Program Cultural Enrichment Funding will support students in the College's Honors program for a Connecticut Forum performance in Hartford. **\$1,000**
- Training equipment will be provided to give students the opportunity to practice phlebotomy skills in a simulated setting prior to performing patient draws. **\$1,000**
- Funding will allow the purchase of the additional equipment needed to deliver an interdisciplinary laboratory-based course for non-science majors. **\$997**
- Support for the college's Transitional Year Program will provide welcome packages, information, and group events that will foster a sense of community and improve college readiness by smoothing the transition from high school to college. **\$800**
- Community Eye Care Day will receive funding for materials that will help to provide eyeglasses for up to 64 community members in need. **\$750**
- Criminal Justice Project is a tiered initiative that aims to develop college and community partnerships while increasing the level of professionalism within the MXCC Criminal Justice program through outreach to new students, enrolled students, and criminal justice organizations in the community. **\$400**
- The Literary & Historic Connecticut proposal will receive support to bring guest lecturers to campus to enrich composition classes. \$400
- A Public Health Fair organized by the Introduction to Public Health class will be sponsored through funding for promotional materials for the campus community and the larger community as well. \$400
- A Life Stories Project will focus on interviews with residents of Covenant House to document their life stories on videotape as a learning tool and means of connecting with another generation of citizens. **\$891**

# **PRESIDENT'S MESSAGE**

I think about sustainability all the time, not only because it is a strong personal value of mine but also because it is a strategic priority of Middlesex Community College. Now, because change is constant and visible all across the globe, the focus of the sustainability movement has shifted toward building resilience. Those who are resilient are adaptable, and the chances are good that they will survive and even thrive in the face of all this change in the environment.

There couldn't be a more apt parallel to what is happening in higher education across the country and certainly in Connecticut. The impacts of this changing environment on colleges and universities are profound and irreversible. The



institutions that will prevail are the ones that are nimble enough to adapt.

The biggest challenge in public higher education in Connecticut is the decline in state support against escalating costs. As we seek solutions to this challenge, our community college students serve as the best models for resilience because a great majority of them have faced financial challenges their whole lives. And yet, in the nearly fifty years of Middlesex Community College's history, over 80,000 students have registered for our credit and non-credit courses. The students have sorted out how to afford college by working with what is available from the state, the federal government, scholarships provided by the Middlesex Community College Foundation, and what they themselves can earn. For each student, each year, the calculations change. What is inspiring to me is that 80,000 students have figured out how to attend our college by maximizing the resources available to them in their local environment. That is resilience on a grand scale.

Together with the Middlesex Community College Foundation, our college community is dedicating itself to building resilience by doing what our students do, developing our assets and maximizing our resources. Over the last few years, we have revitalized our programs in new media, health and life science, engineering, and developmental education. Our librarians, faculty, and staff have embraced an innovative, forward looking approach to student success by creating a Learning Commons. We mobilized our communications team to expanded our outreach; traditional media and new media highlight the resources available at Middlesex that sustain resilience for students through higher education and lifelong learning.

We aspire to a day when everyone we meet in our community is familiar with us and has been on campus at least once. Donors give confidently and generously when they understand both the need and impact of their donations and when the Middlesex student is a face they recognize... a neighbor, a classmate, a friend or colleague. Collectively, our students and all of our alumni make living in this part of Connecticut something we cherish and would wish for others. Making those connections visible within our community widens the circle of donors and creates community. That is working on change, sustainability and resilience – all at the same time.

Thank you for your historic commitment to our students for nearly fifty years and for your ongoing confidence in our mission. With your continued support, Middlesex Community College will be among those institutions that thrive far, far into the future.
