### A. OVERVIEW---Welcome Statement

#### ( COURSE SYLLABUS; see part B, below)

In this start-up to the course, please read carefully the info on the course tools, listed below, to use in learning about American national government and politics. Here are general guidelines as to your study pace in using the course tools.

I commend you in wanting to learn more about this subject as certainly American government and the actions of our politicians are constantly in the news and their actions have consequences in our lives.

When President Obama was at the beginning of his new presidency and for 8 years, his positions on the country's issues/needs and policies, of course, had impacts. For example, as college students, early on in his administration, President Obama pushed for lowering banks' interest rates that are charged in student loans. What can be more consequential than the amount of extra interest you will owe in the future!!! And there were many, many other issues which had an impact in your lives, especially Obamacare.

Similarly, President Trump's reign already has had many consequences. There will be a lot for us to become more fully informed for graded discussions. The first introduction assignment of the Discussion units requires you to think more concretely about Trumpian ruling and policies. And the course will address related issues to topics you raise in your introductions.

Another tip: this is not a history course and what you learned in high school U.S. history is but necessary, informative background to what goes on today. Thus,

this course provides new concepts from a political science perspective in what you will be learning. Some, very few past students assumed that just repeating what was learned in high school U.S. history was sufficient. Success in this course comes from understanding the course's concepts, applying, and keeping up with the assignments for your learning.

Key tasks:

1. Read and re-read this Syllabus,
2. Read regularly, **the Announcements and Calendar's** study activities which inform you of each week's requirements,
3. Study the assigned **readings in the Course Content Weekly folders**. There really is a lot of info to learn in this concentrated course which is alternatively "spread out" throughout the traditional, longer semester for studying. So be diligently persistent with vigilance in focussing on some many concepts, ideas, and issues in the readings!!!
4. It is very important to follow up with each week's Discussion assignments by reading follow-up information which I provide to each Week's study folder, after the postings are logged. In other words, after each week's postings, you can refer to "Instructor's Add-ons" which provides elaboration on info of the Discussion study concepts.

There will also be a "self check" list of questions on a given week's major concepts. Having info on these questions are a review and "reality self check" and will be very useful a prep step for the 1st exam.

I also provide at the bottom of the Discussion units, a separate open unit for questions, any questions, regarding an assignments and the ideas/concepts related to it. No matter how basic the question is, if it is on your mind and needs to be answered to proceed with an assignment, then indeed post your question and/or send me an email about what you are questions. Clearing up questions is a key to fuller understanding and success in this course. So step right up with your questions.

## SYLLABUS

### I. Scope of course

This course examines our society's politics and its patterns from the Constitution, congress, judiciary, and presidency. Topics of study include political ideologies, interest group pluralism, elite influence, citizen alienation, elections, institutional power, democracy's requirements, and others. Present-day issues will be analyzed from the framework of these concepts. It is part of the pathway of courses to the state's senior colleges and universities.

General learning objectives include becoming politically informed, engaging in political discussions, and analyzing the government's responsiveness to citizens' needs.

Course paperback text---The Irony of Democracy by L. Schubert, T. Dye, & H. Zeigler, 17<sup>th</sup> edition

Course prerequisites: none, additionally, this course, has been deemed transferable to other colleges. It fulfills a general education, liberal arts, and stem requirement for several majors. Gen. Ed.: Social Phenomena fulfillment

MAP designation---This Fall, 2018 course is structured to fit a learning/study sequence of 5 weeks which corresponds to the college's MAP or Middlesex Accelerated Program. It is designed for several majors which allow for a concentrated duration of study so as to obtain the Associates Degree sooner

than the standard 2 year period. HOWEVER, the MAP study sequence also serves non-MAP students and corresponds to a typical, concentrated course offered in the summer months.

In general, past students of summer courses have been academically successful and the educational objectives, study topics, and course requirements are similar to the standard 16 week course.

## **II. Welcome**

As your instructor/facilitator in your learning, I welcome each of you to this course. I have constructed the course to be supportive and encouraging of your interest in the study of society's politics and national governing. Whatever advice you may want to communicate to me at any time to enhance your success in the course will be taken into consideration.

This course has been constructed to foster discovery and learning about range of topics and issues. It requires individual effort from each of you. Please recognize and remember that there is an ongoing expectation that you are willing and able to be an independent learner within the unique circumstances of an on-line distance learning course. I assure you, however, that I will be regularly communicating with you via "Announcements" as to how you should be self initiating for achievement in the course.

### **III. A. General Learning Objectives**

This course is part of a foundation for an individual's liberal arts education and pathway on social phenomenon which potentially nurtures a person's intellectual growth and citizenship for participation in a democratic society.

**Critical thinking, open-minded discovery, creative generalizations, and shared learning are some of the traits of intellectual growth** which will be encouraged through the learning exercises of our course.

This on-line course potentially enables everyone to become part of a community of learners, but, to re-emphasize, you must be self-initiating and self-responsible in undertaking the study requirements of the course.

More specifically, the learning activities of the course are designed to develop your skills in thinking and analyzing current, political events and issues. You will need to devote regular attention to the news media as well as particular Internet sources towards becoming more aware to keep informed currently regarding American politics and government.

The course includes a research assignment that requires using internet news sources, such the [www.washingtonpost.com](http://www.washingtonpost.com), and others for documentation.

You will soon realize, if not already, that politics is extremely complicated and confusing. Some of the confusion and difficulties in the course occur because you are moving beyond just a general awareness of political events in the news to their systematic study.

It's all right to be confused, and the course provides ideas and terms to help you sort questions out. So jump right into the flow of information and knowledge, paddle a lot in keeping your head above water by conscientiously doing the assignments, and ask questions by email of me and by raising questions in the section at the bottom of the Discussion units that is provided.

#### Citizenship and Career Objectives

The ideas of this course are part of your skills development in becoming active in your community and in your career pursuits. The course provides information for you to understand politics for participation by being an advocate of your values and beliefs, **through social engagement**, that hopefully will be a benefit to yourself and to your community.

Learning about constructive, productive politics can also further your endeavors in your career field. Your work life will require you to understand its organizational dynamics, and the constructive political skills it calls for in one's career advancement. Many of the discussion topics of the course will stimulate your thinking about the positive role politics can have in one's worklife. Really.

#### **IV. A community of learners**

Beyond your independent studying, we are also a community of learners. Even though we won't be together in the typical college classroom, it is my expectation that we will be engaging each other via threaded discussions on a web site Discussion Board and by e-mails about the topics of the course. I encourage each of you to be honest and candid about the issues of the course. I believe we have a lot to learn from each other.

While we will be learning from each other, it is my expectation that we each should always endeavor to be considerate and respectful of each other's views--- even as we analyze, discuss, and advocate positions on the issues confronting the country and its citizens. I encourage candor in your communications, but you should do so in a civil manner.

Very likely there will be some “stressing” in this sort of course which involves differing views regarding politics; but everyone is expected to abide by the norms of tolerance for open expression of ideas. No one should be targeted for hurtful messages by someone due to his or her views. Please be mindful that this is a college level of learning and we must be responsible in our academic privileges.

**Your major (or possible major):** Some in the course may be a Criminal Justice curriculum major or Human Services or other disciplines for which American government and its politics does and can have direct impacts. As you think about the course's concepts and issues, you might bring some of the concerns from your major to the required Discussion postings.

For example, we explore judicial review in terms of political science's concepts about elites. We do not delve extensively into its historic, legal interpretations by the courts as that consideration can be explored in some the CJ courses.

Political Science's perspective provides its own discipline's concepts and method of analysis. It does not fall solely in History or another discipline's mode of thinking; in other words, we study more than who did what and when and look into the why. In the Lecture file, I provide a framework from political science, “Thinking about politics,” for you to apply to your discussion postings and exams.

## **V. Grading Procedures and Standards**

Assessment of your learning occurs in a variety of ways: e-mail feedback, the research paper and exam grades, and feedback comments, when warranted, on some of your discussion postings in addition to its scores. Grades for specific activities are useful and necessary. towards improved learning and overall academic achievement.

The following is the grading schema for the various assigned activities. Overall, there are four areas for grades: Discussion board comments/analyses, a research paper, and two exams. Exams do not cover the whole term's concepts; however, they require connecting or integrating of ideas between sections of course material.

Each of these areas will be given the standard "A" through "F" grade with corresponding numerical points of "100" to "0." **The two exams each will weigh 40% (1st) and 30% (Final) of the course grade, discussions and the paper are weighted at 15% each. I will be scoring your required, posted comments from 10 to 0 points. Then I will average them for approximately 1/3rd towards an averaging for a course grade.**

However, your final course grade is not solely averaging of scores. As is an instructor's responsibility, I look for a pattern of progressive improvement. Thus, having a momentary slump does not preordain you to a low grade, but the converse also may apply.

For example, a high term paper does not always "save" a weak exam result which might indicate a weak understanding of important course concepts. My best advice is to work steadily, learn from possible previous week's slip-ups, make gradual improvements in Discussion postings, have strong exam scores, and you will likely do well.

"Surface" and Broader, Deeper Learning

This is a survey course and some may be inclined to settle for beginners' "surface" awareness of American politics. Nonetheless, I will be "pushing" you towards a "deeper learning," which higher scores are signs of.

I provide guidelines throughout the assignments as to what needs to be done as you study in gaining this "broader, deeper learning."

### **Discussion postings and grading criteria.**

1. As you respond to a particular question, your comments should connect with the assigned reading material or ideas you have obtained from another significant source, such as from the Internet which must be cited.
2. Try to be concise and stay on topic as to the question posed. If the question logically leads to another area, make the connection clearly as you develop your position.
3. Try not to ramble or sermonize as in a "rant." I know we each may feel strongly about various issues, but endeavor to develop your position logically, and based on facts or data, that can be verified.
4. Be a critical thinker. Ask yourself if you're being somewhat detached and objective about the topic. Your moral or normative orientations are relevant, but you need to decide how much they should shape your

position on a particular question or issue. The critical thinker is able to recognize one's own subjectivities as well as others' biases.

5. A normative orientation can help crystallize discussion, but should not contaminate clear, valid reasoning. Again, I provide a framework, "Thinking about Politics," on how to undertake political analysis which involves seeing cause-and-effect with conditions that shape political outcomes. I encourage to read that overview as it can enhance your thinking and discussion score

In summary, I will be assessing your comments as to a. reflecting that you accurately read the assigned material that is related to the question, b. inclusion of facts that make for sound generalizations, c. the logic of your position, and d. independent and original thoughts brought to the discussion question for all of us to be challenged by as a community of learners.

When questioning your discussion scores, ask yourself if your posting actually does include all the required elements listed in situations where you might want to appeal a grade score.

I will not be providing further explanations to every Discussion postings. It is usually very informative/useful to compare your analysis in terms of details to others which are posted. It is usually very obvious which comments are more fully thought about with research undertaken.

A discussion analysis that receives a 10 or 9, which is an "A" does what I spelled out above. It references terms from the assigned readings, and from news events---and especially the information I provide in my overviews in the Lecture file which are related to the discussion topics. An "A" posting has details and logically, more fully develops ideas. It also contributes new and independently thought out ideas in response to the topic or questions.

Analysis which is rated an 8 or "B" includes some terms, but may also have errors in what is said and is not entirely accurate as to what is described. Some of the generalizations may not be adequately developed and thus is less informative and persuasive.

A "C" rated discussion posting can be too general and displays sketchy information about the topics. Comments scored at 7 or less lack elements of the preceding 3 types of answers. Lower grades may also be because the required discussion was posted very late or not at all.

**More on scores and grades:**



**A—90-100—10-9 points (to a posting)**

Analysis is excellent with many connections to course concepts. Has supporting examples or evidence, unusual insights, and independent reasoning in the explanation.

Information is factually correct and provides verifiable details from cited sources. Conclusions logically following from the provided information.

**B—80-89—8-8.9 points (to a posting)**

Good explanation which uses pertinent supporting examples and reasoning. Most information is factually correct and several valid generalizations, but also has some weak or under-developed propositions

**C—70-79—7-7.9 points(to a posting)**

A mix of some solid and some weak generalizations which meets minimum required by the assignment, but some statements are questionable and insufficiently developed. Sketchy or minimal application of pertinent course concepts.

**D—60 – 69—6-6.9 points (to a posting)**

Posting does not meet the minimum required for assignment by lacking application of concepts and not pertinent to the topic or question. Factual inaccuracies or reasoning flaws, and response is too general and lacks specific evidence overall.

**F— 59-0—5.9-0 points (to a posting)**

Posting does not directly address the discussion questions or assigned topic. The response fails to support assertions with relevant examples, major flaws in reasoning, explanations are unclear, displays inadequate understanding of main concepts. Did not complete the assignment.

(Note: This grading format is solely for the instructor's political science courses.)

And by the way, I encourage valid, considerately made corrections to anyone's comments made in the postings. I certainly am not infallible and if I state something that is erroneous, or from anyone, then, make your contribution in correcting any misinformation with verifiable info.

As to your concerns about your grades, I will, of course, discuss any of your questions via e-mail. and, if the matter is a generalized concern, I will post any clarifications as an **Instructor's Add-ons item** or in an Announcement regarding the particular concern.

While grades are an understandable concern, please be reassured that I am open to constructive, confidential e-mail discussions as to a fair grade regarding your various efforts. So try not to stress over them too, too much. While most of our email communication will occur through the course's formatted system, more confidential matters can be communicated via this course's email, message icon/format.

Extra credit--While I prefer students to focus more on putting the time in to doing well on the assigned activities and thus get maximum points, some are interested in extra credit. There are activities which can be undertaken after the 1st exam results to potentially add points to your grade average standing.

1. There is an orientation trip to the Connecticut General Assembly which provide info about politics through the college's credit-based state Legislative internship for students. I will post an Announcement about the opportunity to visit the G.A. under the guidance of Professor Tad Lincoln.

Interested attendees will need to provide a short written report on one's resulting, expanded political awareness from the field trip in confirming what was gained by this valuable learning event. You may even want to apply to the internship which has been a valuable experience with credit, with transferability, for many past college students!!!

2. On written request with accompanying reasons for undertaking an extra credit exercise, I will email a specific worksheet which requires compensatory study of topics of which lessen/lowered any initial low scoring areas. The extra study and additional info provided by you presumedly, if sufficiently correct, should bolster your grade average.

3. You might view a relevant film such as "Nixon" or you should regularly watch the national Sunday morning talk shows such as ABC's "This Week in Review," the Fox new channel on with Chris Wallace, or another one which reviews the week's significant political events. Also there is the PBS's excellent news analyses nightly. From these or other sources, your analysis must apply course concepts. Also, refer to item 5.b as to another possibility from Chapter 13 in investigating present day civil rights issues.

In undertaking extra credit exercises, approval is required from the instructor who will offer questions to be explored concerning the bonus work. You need to be in email communication with me on such exercises.

## **Paper Assignments**

A research paper is required and I will indicate its requirements and due dates through the Announcement file. Student papers are to be posted on the Discussion Board and I will announce in advance the specific due date.

To re-emphasize, the guidelines indicated above for discussion postings concerning critical thinking, logic, verifiable facts, etc. also apply to the paper assignments.

## **VI. Other college policies and standards**

## VII. College Internet Access

You may look for journal articles in electronic databases from the college or from home. To use computers at the college, you must set up a computer account. You will need your student ID number, also known as your Banner number. Ask a staff person the library or the computer lab about how to do this.

When using a computer from outside the college, you will gain access to the databases through a Proxy Server. You can contact the college's reference librarians for assistance in learning how to access its resources from outside the college. You can find many excellent and useful databases listed there. Two databases which may be most useful are MasterFile Premier and Advanced Academic ASAP. Each database includes online help.

## VIII. Main Course Study Requirements

1. Each week you must **often check "Announcements,"** in the course's web site for your assigned, required study activities, related readings, and due dates. This is a must; so regularly check the "Announcements" as it will contain updates and reminders regarding weekly activities.

2. Go to **Course Content's Weekly Folder** for required readings which are in addition to the assigned, corresponding text chapter for each Discussion postings' topics and questions.

3 Again, I provide further elaboration/feedback on course concepts and discussion topics in an "Instructor's Add-ons" in each Week's study folders, which you must read regularly.

Note that some of the **ideas/info from postings and especially the Instructor's Add-ons** will later reappear in some variation in the exam questions. Taking notes from other student comments of our shared discussion postings can be useful information for more fully formed answers in the exams.

4. On-line study is an active work-in-progress. There will be occasional modifications due to emerging newsworthy items and issues that are relevant to

our study. Rest assured that notice of modifications will be given in advance and will not deviate significantly from the general learning activities

For difficulties in reading assignments due to computer formatting, I suggest that you call the Distance Learning at 860-343-5756 for assistance in these technical difficulties.

## IX. Instructor Communication and Contact

Most weekly course communication should be through the “Announcements” file on the Home page and course email system. I will endeavor to respond to your general messages within 24-48 hours. There will be an opportunity prior to the exams for on-campus, voluntary, review with classmates which I post in Announcements as to when and where.

Graded assessment on assignments, and particularly exams, will be posted in your Grade book. Your discussion postings scores are indicated with the posting.

To re-emphasize, the guidelines indicated above for Discussion Board comments concerning critical thinking, logic, facts, etc. also apply to the paper assignments.

## X. On being currently informed

I want to strongly emphasize that this distance education course really assumes and requires that you are regularly, if not daily, accessing valid, useful Internet sources in making yourself informed about current political events and issues. All the major newspaper and T.V. news sources provide abundant information over the Internet and you should bookmark some of the web sites. For example, <http://www.washingtonpost.com/> has links to “Politics,” “Congress,” etc. which contains tons of news reports and analyses. Similarly <http://www.pbs.org/> has a link to the “News Hour” and you can download useful information from that television news source which is on Public T.V., usually channels 16 and 24. Furthermore, take advantage of the audio reports on NPR.org which are sources of lively, stimulating information and makes thinking about politics easier. There, too, more conservative news sources such as Fox News and The National Review for other views.

Our open society provides for an abundance of other news sources such as magazines and journal such at <http://www.thenation.com/> which is a source of “progressive” political reports and analyses. The conservative magazine, The National Review, is a contrasting source for your thinking. In short, as a self- initiating, independent learner, you

are required to seek out information, cite the sources, and make timely information part of your posted discussion comments. Since we are not together in a real-time classroom, you cannot pickup info from classroom discussion and thus must do a lot on your own and at your own pace. You will discover that there are a lot of lively, controversial sources such at <http://www.moveon.org/> and others, but refrain from relying too much on extremely partisan, ideological sources.
