### **SCOPE OF COURSE:**

The study of the act(s) and mental state(s) which make up the elements of a crime. The analysis of these criminal elements will allow exploration into a wide spectrum of criminal law including felonies and misdemeanors. This is not a course specifically addressing Connecticut laws, although they will be discussed in comparison with other state and federal court decisions.

***Prerequisites:*** ENG 101, ENG 101 E or ENG ALP with a "C-" or better AND completion of CJS 101: *Introduction to Criminal Justice* with a "C-" or better.

### **COURSE OBJECTIVES:**

- Read and comprehend statutory law.
- Identify and interpret essential elements of current modern criminal statutes.
- Evaluate legitimate criminal defenses as applied to criminal case examples.
- Apply constitutional principles that protect the rights of citizens and regulate the passage of laws as defined by legislature, enforced by executive action, and reviewed through the courts.
- Explain key critical concepts as they relate to processes and practices in criminal law.

## **COURSE REQUIREMENTS - OVERVIEW:**

1. Course materials will be delivered via Blackboard and will enable student to complete their academic work in a flexible manner, completely online. The course is broken down into five weeks, the course materials will become available as follows at 11:59pm:

3. You must contact the instructor in advance if you have a good reason to miss an assignment or exam. Exams will be unavailable to complete after their due dates unless you receive advanced permission from me for an extension.
4. Reading assignments must be completed before completing the discussion forum. Questions may be posted on the discussion forum to assure that the readings have been completed, the materials understood, and to stimulate class discussion.
5. Assignments must be turned in on time. Late work will not be accepted. Instructor reserves the right to modify this rule only in exceptional cases.

## **EXAMS:**

Exams will be online with a 90 minute time limit. They are a combination of multiple-choice, true and false, fill in the blank, matching, and/or short answer. Exams are not generally cumulative, but may be semi-cumulative if necessary. Exam material comes from textbook reading, lecture material, chapter PowerPoints, or any other material posted in the Blackboard Shell.

- Exams must be completed before the deadline of 11:59p.m. on the due dates. Late submissions will not be accepted. (Exams submitted after the due date at 12:00a.m. and later will not be accepted.)
- Please make certain to read all the chapters and complete all assignments prior to starting the exam.
- Please note that it is the student responsibility to make certain that they have a continuous internet connection for the duration of the exam. Exams will not be reset if they lose internet access during the exam. Once an exam is submitted or closed, it will not be reopened.
- Once you begin the exam, you must finish in one sitting.

- **Cheating of any kind will not be tolerated and will result in a grade of “F” for the course and immediate referral to the Academic Dean for further disciplinary action.**

### **DISCUSSION FORUMS/LEGAL PUZZLES:**

There will be legal puzzles posted for each discussion forum. The legal puzzles are located in Blackboard within each discussion. Students must complete all 5 legal puzzles.

The legal puzzles in this course all relate to real life cases in which students must analyze, deduce which applicable laws apply, and then answer the legal question being asked. The main objective of these legal puzzles is for students to utilize critical thinking skills and apply information that they are learning in the course. In this course, the legal puzzles will focus on the case law discussed in textbook.

Each student must post his/her individual response to the legal puzzle questions on the **Discussion Board and submit it through SafeAssign by 11:59 pm on Wednesdays**. Late work is not accepted.

Students must interact with other students in the course by posting questions and addressing the initial posts of **at least two** of their classmates. **Response posts are due on Sunday evenings by 11:59 pm**. Response posts need to be made on different days of the week. These responses must be informative and contribute to the advancing knowledge of the topic. “Good job,” or “nice post,” are not acceptable. In order to receive full credit in the “Class Participation” section of the Grading Rubric, among other things, students must respond more than the minimum of twice.

### **Initial Post: Legal Puzzle Requirements:**

- Minimum 300 words in length – (refers only to the body of your response)
- 12 font – Times New Roman
- Proper grammar, punctuation, and sentence structure
- Supported by two scholarly sources – one will be the textbook and the second is the student’s choice. **Wikipedia** is not a scholarly source. Please refer to the “Criminal Justice Writing Resources” section on the Criminal Justice Program BlackBoard shell.
- **In text citations and references required.**
- Please note that all rules in regards to plagiarism and proper citations must be followed.
- **Type your legal puzzle in WORD and then paste it into the discussion forum AND submit it through the Safe Assign assignment module. The assignment module will check the document for plagiarism.**
- \*\*\*\*When you have a question about citing information correctly – ASK FOR HELP!\*\*\*\*
- **DO NOT** send assignments via a message or email – they will not be accepted.

### **Response Posts: Requirements:**

- Respond to **at least 2 classmates'** initial posts (for full credit, you must have three or more responses).
- Each post must be at least 125 words in length.
- Response posts must be made on different days of the week: ex. Monday and Wednesday.
- 12 font – Times New Roman
- Proper grammar, punctuation, and sentence structure.
- Supported by one scholarly source – either the textbook or another scholarly source.

### **QUIZZES:**

**Reading Quizzes:** Students will have to complete a chapter reading quiz. Each reading quiz will pertain to assigned chapters in the textbook. The format of the quizzes will consist of multiple-choice, fill in the blank, and/or matching. The time limit for each quiz will be 30 minutes. Once again, it is the student's responsibility to ensure that they have continuous internet access for the duration of the quiz. Quizzes will not be reset if a student loses their connection or closes the exam.
